About

Metrochem is a customer-driven company with a focus on chemistry and innovation. At Metrochem, we understand our responsibility to deliver high quality pharmaceutical products and we keep pushing ourselves to continuously improve and achieve our vision of providing reliable end to end pharmaceutical support in high growth, high impact therapeutic areas.

We began our humble journey in the year 2004, with a single unit Active Pharmaceutical Ingredient (API) manufacturers with 2 products in our pipeline. Quickly, we backward integrated to intermediates by starting our Intermediate manufacturing facility in 2005. We then forward integrated to semi-finished formulations by starting our pelletization facility in the year 2006. Over the course of years, we started 2 more intermediate manufacturing facilities to fulfill our upstream needs.

Since our inception, we focused on generating value through vertical integration and continuous improvement of our infrastructure and manpower. This foresight about the importance of being vertically integrated allowed us to be always one step ahead of the competition.

It helped us better control the quality of the ingredients that go into the final product, have better command on the pricing and be extremely efficient in terms of deliveries. We have also focused on hiring the right, qualified teams to oversee the critical safety, production, QA, QC and Regulatory activities. Over the years, our ground-level efforts, coupled with our expertise in product development, helped Metrochem clear several agency audits such as USFDA, PMDA, WHO-GMP and enabled us to become a strong, reliable and trustworthy brand.

At Metrochem, we never rest. We always push ourselves to achieve bigger and better things. To extend our impeccable service to the global markets and to meet the increasing demand across our portfolio, we have initiated the construction of our green-field 10 acre Vizag facility in 2012. It was built as a gateway to Metrochem's foray into the regulatory markets.

The plant has a reactor volume of 2500KL with a range of 0.5KL to 15KL. The unit is manned by around 1050 well-qualified and experienced pharma professionals. Commercial production commenced in late 2017. As of first quarter of FY 2022-2023, we have filed 47 USDMFs from this facility.



Research & Development Focus

At Metrochem, we have a strong zeal for innovation and readiness for investments in Research and Development. This attitude has trickled down from the top, with our founder Dr. N.V.Rao being an expert in organic chemistry. We have extensively worked on and delivered new products across a wide variety of therapeutic segments and as a company, we have built strong expertise in new product development.

With R&D efficiency as the core competency, Metrochem expanded its product portfolio from 2 to 300+ within a very short span and this number has been continuously increasing. To date, Metrochem has filed more than 68 patents and 14 patents have been successfully granted.

We also offer Contract Manufacturing, Contract Research, and Custom Synthesis services. We have a stand-alone R&D center located in Hyderabad with State-of-the-art analytical facilities and over 250 scientists. Our R&D focused culture allows us and our team to work with passion and commitment, and therefore efficiently synthesize novel and economical routes.

We have invested \$5 million in 2019 alone to further upgrade our Analytical R&D. Annually, we invest 10% of our revenue in development activities. We also have a dedicated Formulation R&D center and a Process R&D lab that focuses on the application of flow chemistry and chemical engineering principles to improve our manufacturing capabilities.
