



MUSCLE RELAXANTS, PERIPHERALLY ACTING AGENTS

Therapeutic indications

Cisatracurium Kalceks is indicated for use during surgical and other procedures in adults and children aged 1 month and over. It is also indicated for use in adults requiring intensive care. Cisatracurium Kalceks can be used as an adjunct to general anaesthesia, or sedation in the Intensive Care Unit (ICU) to relax skeletal muscles, and to facilitate tracheal intubation and mechanical ventilation.

MUSCLE RELAXANTS, PERIPHERALLY ACTING AGENTS

This medicine is indicated in adult and paediatric patients (from term neonates to adolescents [0 to <18 years]) as an adjunct to general anaesthesia to facilitate tracheal intubation during routine sequence induction and to provide skeletal muscle relaxation during surgery. In adults rocuronium bromide is also indicated to facilitate tracheal intubation during rapid sequence induction and as an adjunct in the intensive care unit (ICU) to facilitate intubation and mechanical ventilation.


HYPNOTICS AND SEDATIVES

Therapeutic indications

For sedation of adult ICU (Intensive Care Unit) patients requiring a sedation level not deeper than arousal in response to verbal stimulation (corresponding to Richmond Agitation-Sedation Scale (RASS) 0 to -3).

For sedation of non-intubated adult patients prior to and/or during diagnostic or surgical procedures requiring sedation, i.e. procedural/awake sedation.

ANTIHYPERTENSIVES

Hypertensive emergencies (e.g. a critical rise in blood pressure), severe and very severe forms of hypertensive disease, hypertension resistant to treatment.

Controlled lowering of blood pressure in hypertensive patients during and/or after surgery.

- torsade de pointes;
- the control and prevention of seizures in severe pre-eclampsia;
- the control and prevention of recurrent seizures in eclampsia.
