

# **Facilities**

### Manufacturing:

Global Pharma's facility is comprised of over 1 acre of land located in the heart of the exclusive pharmaceutical industrial area in Alathur, Chennai - promoted by the Government of Tamil Nadu. 42,000 sq. feet of this expansive area has been built and designed for the manufacturing of tablets, capsules, ointments, liquid orals, small and large volume parenterals, eye/ear drops, sachets. Further expansion of 17,000 sq. ft on the second floor and 10,000 sq. ft. on the terrace is been designed to meet the standards of SRA.

The manufacturing area is designed for class 100, 1,000, 10,000 and 1,000,000 with required sophisticated HVAC system containing free filters of 10, 5 & 3 microns and terminal HEPA, conditioned air supply with regulated temperature, pressure differential and humidity.

The facility is equipped with a reverse osmosis plant coupled with a DM plant and UV sterilizer to ensure an uninterrupted supply of purified water. A Multicolumn with a continuous circulation system is also installed.

### Beta-Lactam facility:

A beta-lactam unit is functional as per WHO cGMP standards, equipped with separate raw material stores, a QC lab and a finished product storage area with a team of dedicated factory personnel to carry out the various procedures.

We offer beta-lactams as tablets, capsules and oral powders for suspension. Oral powders for suspension are offered in both bottles (glass and PET) and in unit dose sachets. The installed capacity is 10 million capsules and 1000 kg of oral powders per month / shift.

### **Packaging**

Products are offered in aluminum strips, blisters and Alu-Alu packs. The installed capacity is 10 million capsules in a month / shift.

#### Tablets:

Our facility is equipped with sophisticated RMG, octagonal blender, fluidized bed dryers, double rotary punching machines, autocoater and more. The tablet section is capable of manufacturing uncoated, enteric coated, sugar coated and film coated tablets, with a production capacity of more than a million tablets on a single shift basis.



## Injectables:

Keeping in mind the need to deliver various dosage forms to international markets, we have commissioned a sterile facility to manufacture small and large volume parenterals, eye/ear drops.

The facility is equipped with form fill and seal machinery to manufacture IV fluids, ophthalmic and ear drops. This establishment includes air handling units with HEPA filters, purified water systems, quality control & microbiology lab and more.

Currently, we offer various products dosage forms, ranging from 1 ml to 100 ml. The installed monthly capacity is 350 liters per shift.

# Hard Gelatin Capsules:



This facility offers a wide range of products in capsule form. It is equipped with AF-25T Automatic filling machines.

This facility is equipped with automatic filling machines to produce large volumes of liquid orals.


HEPA filters are installed in both manufacturing and filling areas. The products are offered in both glass and PET bottles.

#### Ointments:



The ointment and cream section is equipped with Automatic filling machine with varying capacities, that are capable of manufacturing up to 300 kg of ointment / cream per shift.

We offer oral powders ranging from 1 gram to 30 gm. Our product range includes electrolytes, life style products and nutritional supplements.

The quality control department is highly equipped with instruments like HPLC, UV, IR, TOC, Dissolution apparatus etc.

A separate walk in chamber is installed for stability studies for existing products and products under development.

Global has a dedicated regulatory team. The RA team keeps abreast of current guidelines of all the African and Asean Countries. Global holds DMF's in CTD format for almost 400 products.
