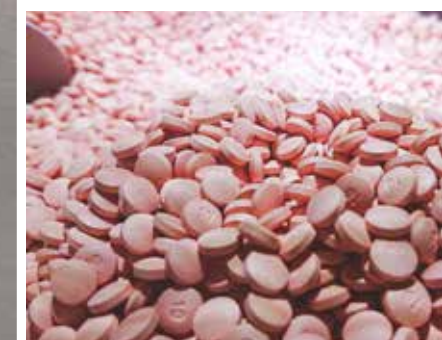
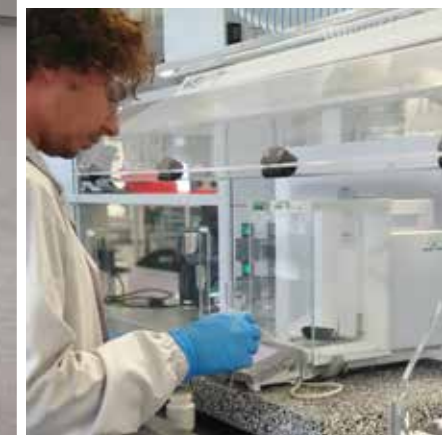
# ABOUT US
