Location and Infrastructure

- ⊞ Manufacturing Site-1 is situated at Sisona, 15 kms. from Roorkee main city . Manufacturing Site-2 is situated at Sikandarpur just 7 kms from Site-1.
- ⊞ Both sites are located on Delhi-Dehradun National Highway No. 334. Nearest railway station Roorkee is just 15 kms. from site-1. National capital New Delhi via road is 200 kms. Nearest Dehradun Airport is 77 kms. from the site. Nearest Tughlakabad container depot for export is 210 kms.
- ⊞ General Injections, Tablets, Capsules, External Preparations, Eye, Ear & Nasal Drops, Dry powders and Oral Liquids are manufactured at Unit-1 at Site-1, Sisona. Oncology Lyophilized & Liquid Injections are manufactured at Unit-2 at Site-2, Sikandarpur. Nutraceuticals & Herbal Products are manufactured at Unit-3 at Site-2, Sikandarpur.
- ⊞ Manufacturing units are constructed as to meet stringent international standards and are well equipped with latest machinery and quality labs.

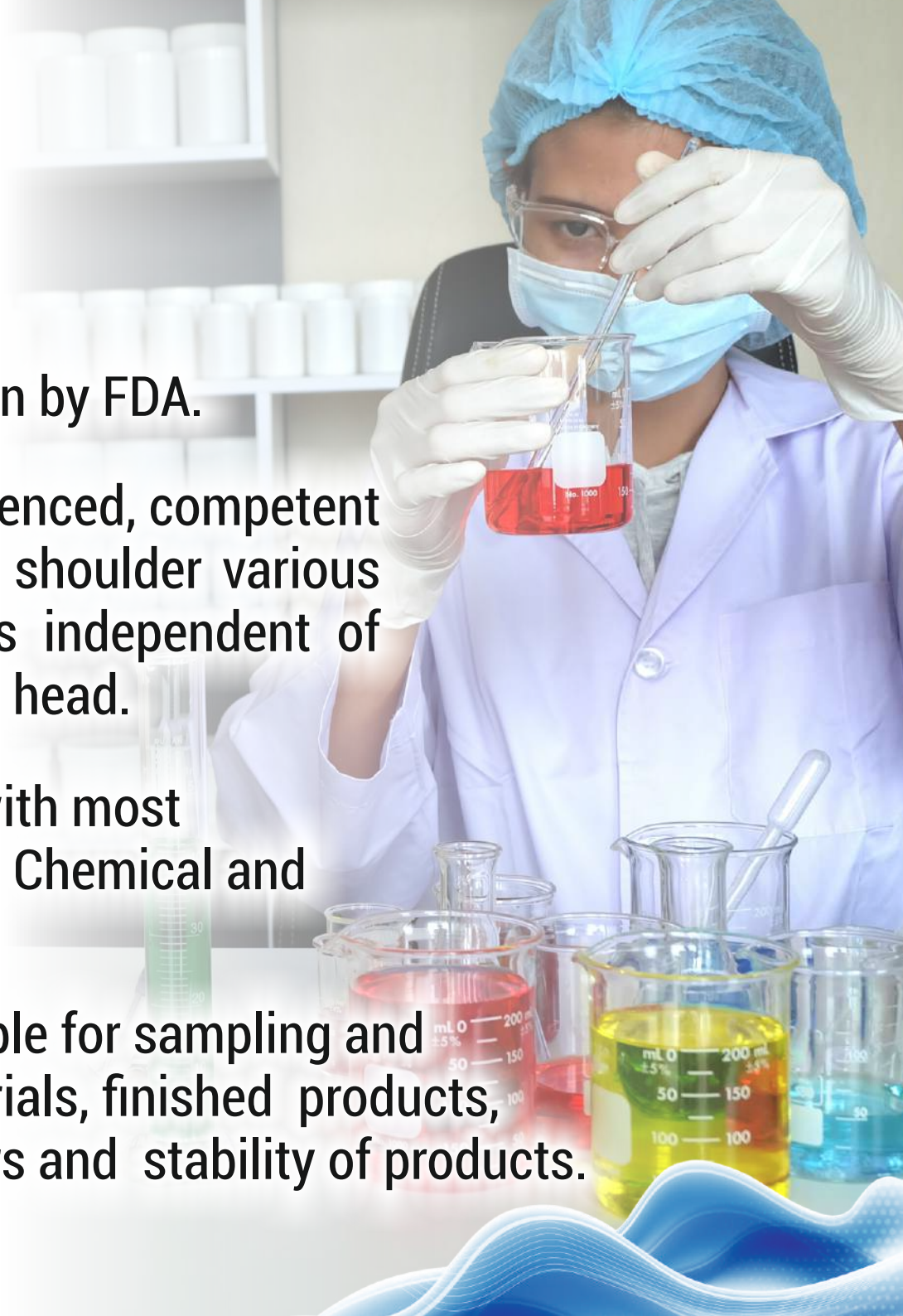
