MANUFACTURING

TIL's manufacturing facility is designed to meet the global GMP norms including US FDA, UK MHRA, EU.

TIL manufacturing facility is approved by Regulatory authorities by various countries and has WHO – GMP and ISO certifications.

The production capacity is capable of meeting any large demands by virtue of which we can deliver the products within the shortest possible time comparable to best in the industry. Current capacity of the plant is as below:

- TABLETS - 4.0 BILLION
- CAPSULES - 300 MILLION
- SYRUP - 25 MILLION
- SACHETS / DRY POWDER - 10 MILLION
- OPHTHALMIC DROPS - 1.0 MILLION

Our well equipped plant is located at serene, pollution free, green environment of Sricity SEZ, Chittoor district, Andhra Pradesh, which is about 80 km north of Chennai. Access to 2 major ports within 80 km reduces the logistics time from plant to port is a definite advantage for timely delivery of products needed by the markets.

Qualified and highly experienced staff having more than 20 years experience in similar field are employed at key points of production.

- Quality is a way of life in TIL and each and every product are put through stringent in process quality checks as well as elaborate quality analysis before release to markets.
- Quality control and microbiology departments is equipped with sophisticated instruments like HPLC, FTIR, UV Spectrophotometer, Flame Photometer, Dissolution test apparatus, Disintegration tester, Friability test apparatus, Millipore water system, TOC Analyzer, M.V. titration, BOD incubators, and Analytical balances etc.

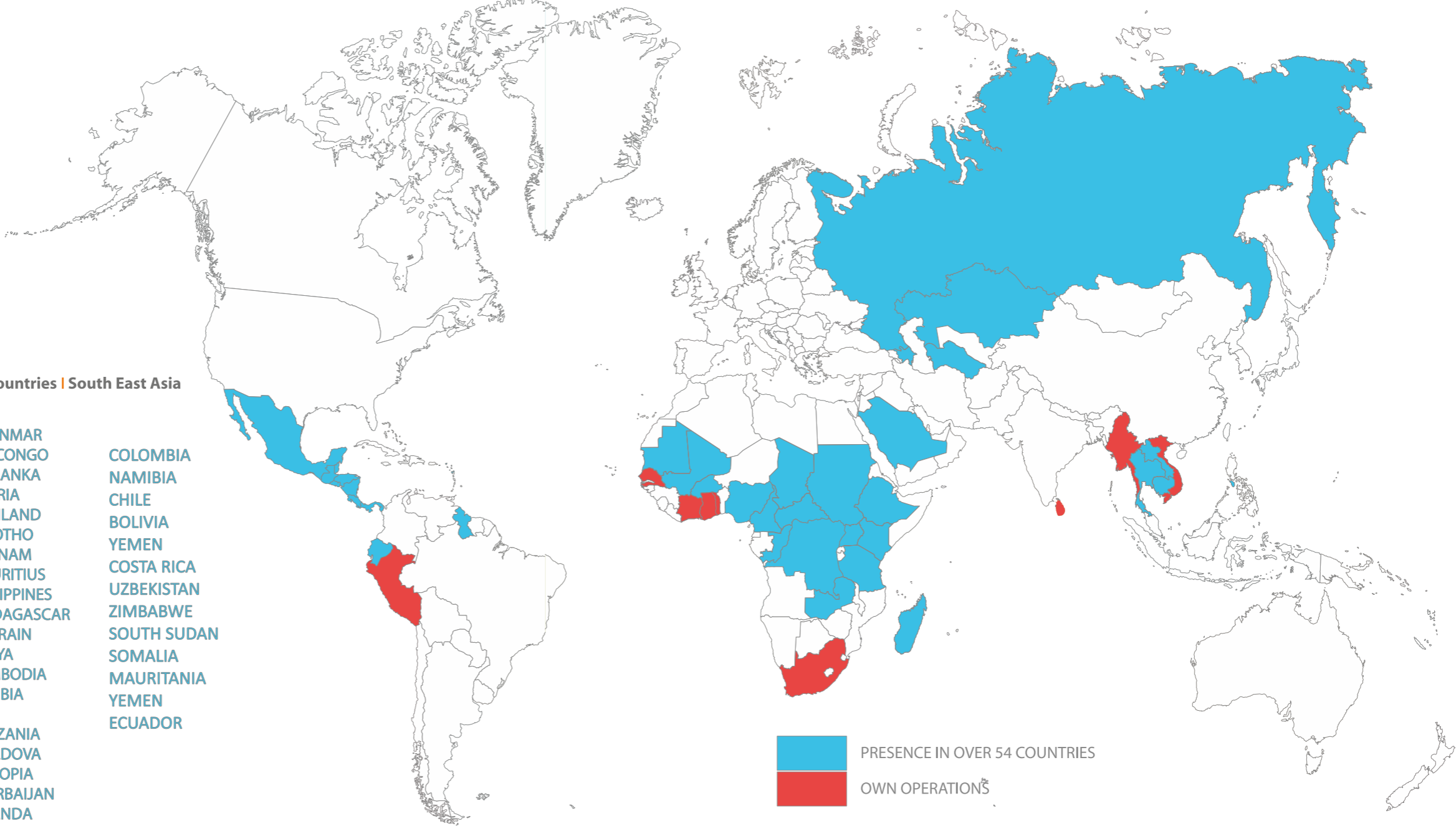
